#### Asst. Prof. Juraj Brozović, DMD, PhD Specialist in Oral Surgery

Juraj Brozović graduated out of School of Dental Medicine, University of Zagreb in 2009 at the top of his class. After continuing with the postgraduate doctoral study in 2009, his doctoral research titled "Analysis of the load transfer properties of different implant-abutment assemblies by digital holographic interferometry" was carried out at the Institute of Physics (Zagreb, Croatia), in collaboration with the Institute for Thermal Turbomachinery and Machine Dynamics (Graz, Austria), introducing a novel method in the field of dental implantology. He defended his PhD thesis in 2014. In 2012 he began his full-time specialist training in oral surgery at the Zagreb Clinical Hospital Center. After passing the specialist exam in 2016, he was awarded the position of scientific associate at Zagreb School of Dental Medicine. As assistant professor in Oral Surgery, he is currently Head of Dental Implantology course at the Faculty of Dental Medicine and Health, University of Osijek. He is an international lecturer on microsurgical approach, soft and hard tissue grafting procedures, and implant dentistry, authoring a de

Juraj is an Executive Board member of Croatian Society for Oral Surgery, member of Croatian Society for Dental Implantology, Croatian Medical Association and Swiss Society for Oral Implantology (SGI). He was awarded multiple awards for the achievements in his studies and research.
